1. Landowner license applications will not be accepted by the Wyoming Game and Fish Department without the approval of the game warden within whose district the areas being applied for are located. To help verify that you are eligible as a landowner applicant, please complete the following:

\* Legal description of the deeded land that entitles you to this license (section, range, township).

\* Is this land held as:  an individual?  a corporation?  a trust?  a partnership?  a limited liability company?  
 joint tenancy or tenancy in common or tenancy by the entirety?

\* If you are a member of the landowner's immediate family, what is the name of the landowner to whom you are related?

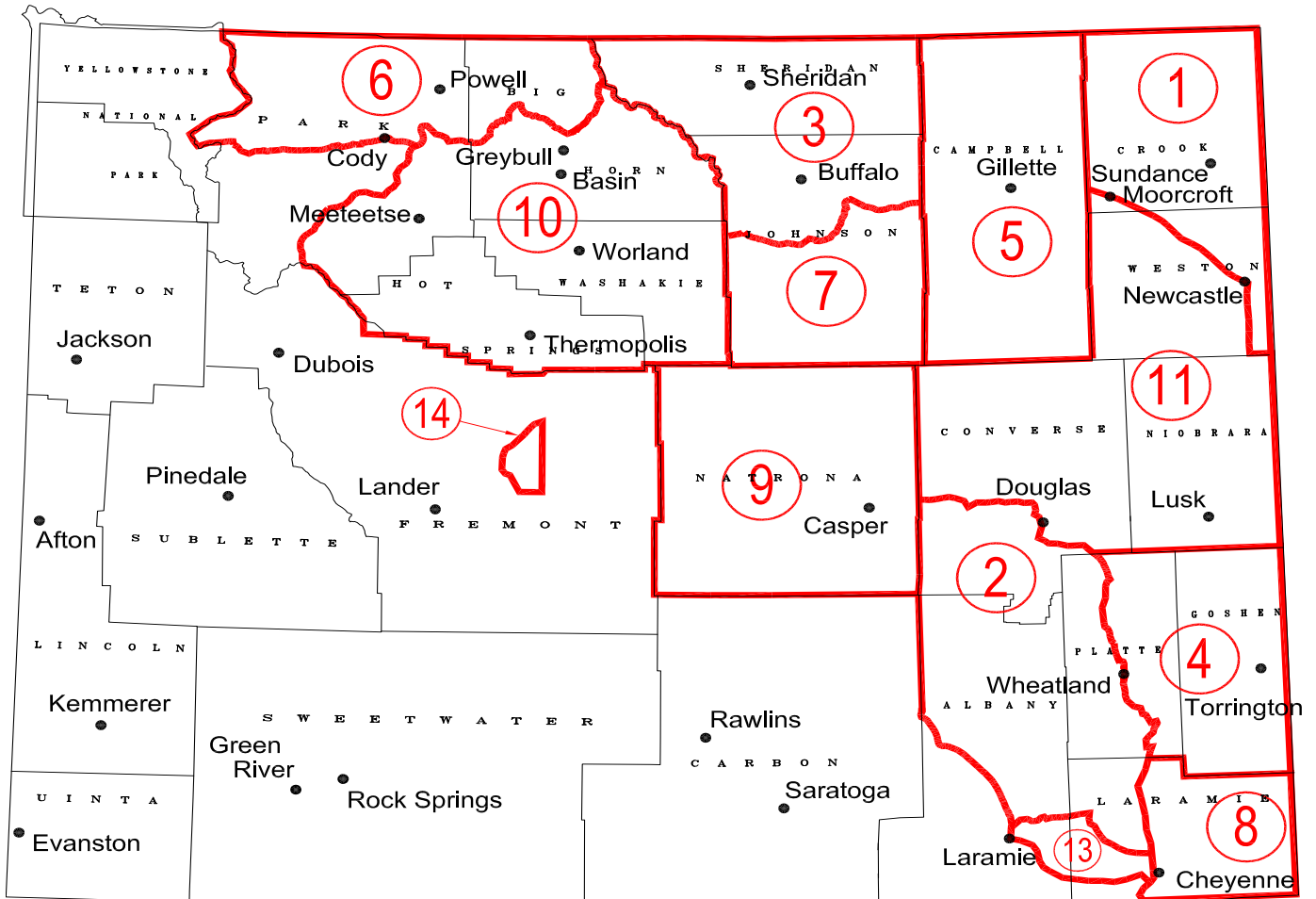
