Each sportsman licensed to hunt or fish in Wyoming, with the exception of Pioneer Bird, Fish and Small Game license holders and Daily Fishing and Daily Game Bird/Small Game license holders, must purchase a single Conservation Stamp for \$12.50, which will be valid for one calendar year. The stamp must be signed in ink and in immediate possession while engaged in the act of HUNTING OR FISHING. Conservation stamps may be purchased from Game and Fish Department offices and license selling agencies throughout the State of Wyoming.

NOTE: ONLY CERTIFIED CHECK, CASHIER'S CHECK OR MONEY ORDER WILL BE ACCEPTED. PERSONAL CHECKS DRAWN ON WYOMING BANKS ARE ACCEPTED FROM WYOMING RESIDENTS. NO TWO PARTY CHECKS ACCEPTED.

NOTE: NEITHER THE U.S. POSTAL SERVICE NOR ANY OTHER MAIL DELIVERY SERVICE ARE AGENTS OF THE WYOMING GAME AND FISH DEPARTMENT. THEREFORE, THE DEPARTMENT CANNOT ASSUME RESPONSIBLILTY FOR MAIL DELIVERY TO OR FROM THE DEPARTMENT. PLEASE ALLOW 15 BUSINESS DAYS FOR DELIVERY OF YOUR REQUEST. IF YOU DO NOT RECEIVE YOUR LICENSES IN A TIMELY MANNER, YOU MAY HAVE TO RE-PURCHASE THEM AND PAY FOR THEM AGAIN WHEN YOU COME TO WYOMING. UNDER NO CIRCUMSTANCES WILL REFUNDS BE ALLOWED.
